- (iv) To facilitate and expedite on land matters for the setting up of Industry
- (v) To facilitate local entrepreneurs in having an interface with industrial associations, Central Govt. Boards and Authorities etc.
- (vi) To attend to all enquiries from all prospective entrepreneurs relating to the law, procedure, practices etc. governing investments in the State and
- (vii) To continuously review the various clearances and approvals required for investment in the State by entrepreneurs with a view to simplify them as also to minimize procedural constraints to ensure flow of investments in the State.
- (viii) Regional Chief Conservator of Forest, Shillong will also be requested to attend as a special invitee whenever so required.
- (ix) In cases requiring urgent/immediate disposal, the Agency would take resolutions/decisions through circulation.
- (x) In case where a member is unable to attend meetings due to unavoidable circumstances he would depute a senior officer empowered to take decisions on the issue which are to be considered in the meeting.
- (xi) The Director of Commerce & Industries will function as the nodal authority to receive and process all references made to the Committee and will also act as "Escort" for intending entrepreneurs.
