- 6. In case of Non-Tribal Supplier/Firm, a copy of up to-date valid Trading License from concerned District Council of Meghalaya should be enclosed.
- 7. The Party is allowed to quote two or three specimens/types for the trophy/logo.
- 8. Delivery must be completed within 30(thirty) days from the date of receiving the supply order.

The undersigned reserve the right to accept or reject any quotation without assigning any reasons thereof or to change the supplier at any time if the supplies of the items are found to be inferior quality or bad workmanship, or not suit with the trophy meant exclusively for Handicrafts Awards of the state of Meghalaya.
